All goods handled by Bower Green are subject to the trading conditions of the British International Freight Association, Road Haulage Association and the United Kingdom Warehouse Association. Copies are available on request.

To summarise, this means Bower Green’s liability is limited by weight, not by value of shipments, in line with all Freight Forwarders

We have vast experience in Freight Forwarding, our hauliers and agents are all trusted and carefully selected. Unfortunately, despite our best efforts, there is the rare occasion when something goes wrong and your goods arrive damaged or even in the case of theft, not at all.

This can cause extreme problems for you and your business, but at least as long as you are covered by Marine Insurance you will not lose out financially.

Goods should be insured for transit by either the exporter or importer. The forwarder can arrange on your behalf, but must be instructed to do so in writing. The forwarder will never automatically insure the goods. It is wise to make sure you know who is responsible for the insurance and that they are aware of this responsibility.

Never assume that the goods are insured during transit. Find out for sure. Otherwise your goods could be travelling without cover, or at best with only limited liability cover. Hopefully you will never need to make a claim but if you do make sure you are adequately covered.
